

FIRST DOMESTIC GREEN MARITIME CORRIDOR

The Port Authorities of Montreal, Quebec City and Trois-Rivières have joined forces in a research project led by the Université de Montréal, as part of the PLAINE - Réseau Québec Maritime program, aimed at mitigating the impacts of commercial shipping and port activities on the environment and natural and human ecosystems.

Over the next two years, the Université de Montréal's Centre interuniversitaire de recherche sur les réseaux d'entreprise, la logistique et le transport (CIRRELT), along with the three port authorities fully committed to the energy transition of Quebec's maritime and port industries, will work together to establish a practical roadmap to support the ambition of a totally carbon-free St. Lawrence system.

THE PORTS OF MONTRÉAL, QUÉBEC AND TROIS-RIVIÈRES JOIN THE NET-ZERO CHALLENGE

In May, the three ports jointly announced their participation in the Canadian government's Net-Zero Challenge. This is a voluntary initiative that invites companies to develop and implement credible and effective transition plans to make their facilities and operations emission-free by 2050. By announcing their membership, they commit to accelerating the decarbonization of the maritime industry along the St. Lawrence maritime corridor.

TROIS-RIVIÈRES EN BLUES



DÉFIS DU PARC NORDIQUE



DODGEBALL TOURNAMENT


Part of the team took part in a dodgeball tournament to benefit the Trois-Rivières Health Foundation. A total of \$1,550 was raised by the team for the occasion.








Alcoa

Alcoa - Aluminerie de Deschambault has continued its engineering activities for the installation of its new state-of-the-art pneumatic unloaders (PDP). This equipment will enable more efficient unloading of the raw materials required by the smelter. A transition plan was put in place in 2023, in partnership with Somavrac, to ensure the unloading of vessels until the project is completed. Alcoa also pursued its action plan to optimize the preventive maintenance of its equipment and modernize certain critical assets. Alcoa, in collaboration with its stakeholders at the Port, is constantly striving to optimize its processes.



QUÉBEC-GATINEAU RAILWAY


New Liebherr 420 crane: A giant step forward in port expansion


Somavrac Inc. acquired a new Liebherr 420 crane, a major investment for the Port of Trois-Rivières. This crane, renowned for its power and reliability, is a strategic asset for the Port. It enables ships to be loaded or unloaded faster and more efficiently, supporting the continued growth of their activities.

New hoppers and innovative conveyor system: Optimizing logistics flow

Recent investments by Somavrac Inc. also include new hoppers and an innovative conveyor system, aimed at optimizing logistics flow at the Port. This state-of-the-art equipment enables precise loading of goods, while the conveyor system ensures efficient movement of materials. These synergies reinforce the Port's positioning as a logistics hub, and demonstrate its commitment to modern, high-performance port operations.







LOGISTEC

After a record year in terms of volume in 2022, Logistec managed to maintain the same levels, despite a general downturn in the market. This was made possible by the company's excellent customer service and flexibility in responding to its customers' needs.

Thanks to Logistec, Trois-Rivières is now a terminal of choice for importers of steel products from Asia. Logistec successfully penetrated this market in 2021 and continued its efforts in 2022. In 2023, the strength of these relationships was confirmed.

Finally, its Trois-Rivières team developed their operational method so as to be able to work on several ships at the same time. Thus, for the first time last summer, Logistec was operating on four ships at the same time, carrying a variety of cargoes.

QSL

QSL, aware of its role both locally and globally, has presented its first MSE (management strategy evaluation) report. QSL is also committed to a process of continuous improvement, good governance and sustainable development, with the deployment of innovative internal programs:

- DATA Measure;
- IMPERIUM HSEE management systems;

Introduction

Sustainable development, focused on satisfying present needs without compromising those of future generations, is an essential approach to ensuring a prosperous future. It involves promoting eco-responsible management that contributes to general well-being and the preservation of our planet. This means improving living standards while protecting human health, preserving the environment, using resources wisely and promoting long-term economic competitiveness.

At the Port of Trois-Rivières, this philosophy requires the full integration of environmental, economic and social priorities at all levels of the company. Over the past year, the Port has undertaken actions and initiatives aimed at reinforcing this progressive and inclusive approach, thereby responding to current challenges while ensuring the ability of future generations to meet future challenges.

Long-term commitment

The TRPA team and its Board of Directors are resolutely committed to supporting the Port's mission to maximize the economic, social and environmental benefits of its activities through exemplary governance guided by a sustainable vision.

As a sustainable Port, we believe that economic prosperity, active participation in the community and preservation of the environment are inextricably linked.

Our commitment is reflected in nine initiatives, balanced between economic, social and environmental dimensions, aimed at guiding our port towards sustainability.

Our 2023 review highlights our efforts in all three areas, demonstrating our concrete commitment to sustainable development.

Actions in line with our nine sustainable orientations

Economic prosperity

Innovative and sustainable governance, guiding the port community to be responsible, equitable, transparent, respectful of the environment and open in all its relations with the community

The Port attaches paramount importance to consultations for its projects subject to the *Impact Assessment Act* (IAA, 2019). They represent an essential step in its innovative and sustainable governance, aimed at guiding the port community towards responsibility, equity, transparency, respect for the environment and openness in all its relations with its environment.

The Evaluation of Environmental Effects Assessment (EEA) for the reconstruction of Pier 17 and the construction of the new Pier 16 was the subject of numerous consultations. The public was invited to interact via the EIA Registry. The following First Nations were directly solicited to react on the potential impacts of the project on their rights and interests: the W8banakiak (Wôlinak and Odanak), the Huron-Wendat Nation and the Mohawk Nations (Kahnawà:ke, Kanesatake and Akwesasne). In addition, Transport Canada, Fisheries and Oceans Canada and Environment and Climate Change Canada commented on the EEE to improve and develop the project in a collaborative manner.

The involvement of all these stakeholders has consequently enriched project implementation by integrating their respective knowledge to reduce or mitigate environmental impacts. As a result, the concerns and issues identified were carefully integrated into the project's EEE, with clear, specific and verifiable mitigation measures to ensure responsible and sustainable implementation at every stage.

Sustainable economic development serving the community by remaining competitive and innovative with green, environmentally-friendly range of services

The Port of Trois-Rivières is proud to be one of three innovation clusters in the Vallée de la Transition Énergétique (VTE), an initiative designed to help accelerate energy transition and reduce the environmental footprint of urban, industrial and port environments. This initiative will focus on renewable energies and the development of technologies that promote a sustainable energy transition.


In the case of the Port of Trois-Rivières, being part of the VTE means a commitment to integrating environmentally-friendly practices and technologies into its operations, promoting the use of renewable energies, reducing its carbon footprint and actively contributing to the fight against climate change. It also implies the Port's participation in research and development projects aimed at increasing energy efficiency and promoting the adoption of sustainable practices in the port sector.



Sustainable innovation to improve the management of port activities in a context of sustainable development and the integration of green technologies

The Port of Trois-Rivières is a founding member of the Centre d'expertise en logistique portuaire. Through this initiative and association, it aims to improve logistics and port activities in a context of sustainable development. The Centre is a partner of choice for the Port, which is constantly seeking to promote inclusive innovation practices and create synergies to develop new knowledge and implement solutions adapted to its needs and those of the Quebec port ecosystem through innovative projects.

The Port has great potential to boost the economy and influence the implementation of innovative, green, carbon-neutral and sustainable technologies, techniques, methods and projects. So, to play its part in the collective future, the Port will sometimes transform itself, for the benefit of the Centre, into a platform for experimentation and learning.



Environment and health

Achieve carbon neutrality by providing strong leadership to encourage our users and customers to make energy choices that reduce emissions, and by investing in clean energy sources

The Port of Trois-Rivières is firmly committed to achieving carbon neutrality and assuming strong leadership in reducing the port community's greenhouse gas (GHG) emissions. To this end, it intends to actively encourage its users and customers to adopt more sustainable energy choices and invest in clean energy sources.

With this in mind, the TRPA vehicle fleet has recently integrated four plug-in hybrid vehicles. This initiative has resulted in a significant 35% reduction in GHG emissions from our vehicles in 2023 compared to 2022 results, from a total emission of 11,400 (2022) to 7,400 kg (2023) of $\rm CO_2$ equivalent. This concrete action demonstrates our commitment to a greener, more sustainable future, while helping to preserve the environment for future generations.



Adapting to climate change by implementing concrete actions to increase resilience and improve the ability of port infrastructures to adapt to climate change

As part of the project to rebuild Pier 17 and build a new Pier 16 at the Port of Trois-Rivières, particular attention was paid to adaptation to climate change. Concrete measures were integrated to increase resilience and improve the ability of these port infrastructures to adapt to the effects of climate change.

Firstly, stormwater management was carefully planned, including more efficient and resilient water treatment systems. This includes oversizing storm pipes to increase stormwater retention capacity, as well as improving overland drainage to promote rapid water evacuation. In addition, the design, construction and maintenance of the port infrastructure were designed to ensure that it is resilient and sustainable in the face of climate change. It was important to meet environmental challenges while ensuring the durability and safety of the infrastructure.



Protecting biodiversity and the environment by taking responsibility for protection and preventing pollution. The port community is committed to reducing the environmental impacts and risks associated with its activities

As part of the Evaluation of Environmental Effects (EEE) for the reconstruction of Pier 17 and construction of the new Pier 16, several mitigation measures have been recommended to contractors to ensure that the project's effects on the physical, biological and human environments are minimized.

In order to protect biodiversity, specific mitigation measures have been put forward, notably to ensure the protection of avifauna, fish and their habitat, as well as species of precarious status such as chiropterans. Below are a few examples:

- Demolition work on the fixed loading/unloading towers will be carried out outside the nesting season for various migratory bird species (waterfowl, waterbirds and shorebirds) and the bat birthing season, both of which run from mid-April to the end of August.
- To prevent fish being trapped when the harbour basin (formed by piers 14, 15 and 16) closes, sound (infrasound barrier) or physical (bubble curtains) deterrents will be used. The aim is to scare away any fish that may be present in the confined area of the basin before it closes
- To reduce the impact on fish habitat, turbidity curtains adapted to local conditions (height, materials, presence of scales and floaters, etc.) will be installed during backfilling operations.
- Monitoring of suspended solids (SS) in the receiving environment, validating the
 requirement for a maximum increase of 25 mg/L compared with ambient levels, will be
 maintained when turbidity curtains are used.

The Port is therefore concerned to reduce the environmental effects and risks that may be associated with this project.





Social and community

Local port culture and identity, by promoting the culture and identity of the port city within which it is located, and by fostering a sense of pride among Trifluvians in belonging to a valued port community

In the spring, the Port joined the Maritime Employers Association (MEA) to launch a major project with Culture Trois-Rivières. Over a three-year period, Culture Trois-Rivières will offer a new, fun and innovative way to discover the history of pulp and paper, through historical cruises on the Saint-Maurice River.

This partnership has made it possible to build two electric pontoons that will evoke memories and emotions for passengers. These cruises take passengers on a journey through the region's industrial past, highlighting the importance of the pulp and paper industry in the economic development of Trois-Rivières. Passengers have the opportunity to relive the defining moments of this industrial era, while admiring the picturesque scenery along the banks of the Saint-Maurice River





Health and quality of life, particularly through its role as a model employer, its support for the creation of quality jobs in the region and its ongoing involvement in the community

The Port of Trois-Rivières strives to distinguish itself as an exemplary employer and a driver of quality job creation in its region. Over the past ten years, its workforce has tripled, from 8 employees in 2013 to 27 in 2023. Its commitment goes beyond simply offering jobs: it aspires to create and support employment that fosters personal fulfillment, strengthens community involvement and contributes to local economic growth. By investing in rewarding professional opportunities, the Port seeks to generate sustainable value for the communities it serves, actively participating in their long-term development and well-being.



A city-port interface that promotes cohabitation with neighboring communities and harmonizes uses in an industrial zone

The Port of Trois-Rivières is committed to promoting a harmonious City-Port Interface, fostering cohabitation with neighbours and the integration of port activities into the urban fabric. As part of this commitment, the Port unveiled two monuments in the park adjacent to its offices, symbolizing its partnership with First Nations. The park has also been renamed First Nations Park, in recognition of the shared history between the Port and First Nations. Before it was an official port, it was a place for trading furs with Indigenous peoples, reflecting the deep historical ties between the Port and First Nations.

The First Nations Park now boasts magnificent works by Abenaki and Wendat artist Christine Sioui Wawanoloath. These artistic creations symbolize the importance of collaboration between the two peoples, and pay tribute to the significant contribution of the Abenaki First Nation to the region. The symbols chosen by Ms. Sioui Wawanoloath reflect the values shared by the two communities, reinforcing the cultural and historical ties that unite them.



Open hands come together under the sun, in broad daylight, in peace. On one hand, the double curves so dear to the First Nations, and on the other, the fleur-de-lis representing the Quebec nation. These hands - these peoples - are joined in a setting of sculpted mountains bordered by the St. Lawrence River, two essential resources for these two nations.



Women and men drawn in the style of a wampum, a beaded belt crafted by First Nations and used to represent meaningful agreements between peoples. The hearts symbolize sincerity and friendship. Finally, the artist's personal vision adorns the second monument, with double curves in bloom under the benevolent sun.
