This notice describes Harbour Dues fixed by the Trois-Rivières Port Authority (TRPA) following section 49 of the *Canada Marine Act* and concerns berthage, anchorage and wharfage fees, as defined below:

DEFINITIONS

« **Harbour Dues** » means a toll on a vessel that comes into or uses the port.

« **Anchorage Dues** » means a charge on a vessel while the vessel is occupying an anchorage area in a harbour;

« **Berthage Dues** » means a charge in respect of a vessel that is secured to or moored at or occupies a berth or part thereof or is fast to or tied up alongside any other vessel occupying a berth;

« **Side Wharfage Dues** » means charges levied on a vessel loading grain in bulk.

« **Wharfage Dues** » means a charge on all goods that are loaded, unloaded or transhipped within the Authority's property by any means of transportation;

« **Passenger and vehicles dues** » means a charge for every passenger and every vehicle embarked or disembarked from a vessel.

EXIGIBILITY AND PAYMENT OF THE DUES

- a) Prescribed dues are payable to the Trois-Rivières Port Authority.
- b) All dues prescribed by this notice must be paid within 30 days of the date of invoice. When dues are not paid within the said period, an additional charge of 1.5% per month or 18% per year of the fees payable shall be applied for each subsequent 30 days period, or portion thereof, that the dues remain unpaid.
- c) Dues prescribed by the notice are in addition to dues prescribed in any other notice or that may be owing to the Authority.
- d) When two bases for calculation are given for a same item, fees shall be calculated on the basis yielding the greater revenue.
